- 54 The development of this PDRA was triggered by the request from some states to facilitate
- 55 operational authorisations for UAS with up to 8 m characteristic dimension which have never flown
- 56 before.

- 57 The PDRA should provide operators and manufacturers the possibility to perform UA test flights to
- 58 develop technology, test components, or analyze specific procedures. It aims at granting enough
- 59 flexibility for a variety of operations, while simoultanesously ensuring a low-risk environment.
- 60 To provide flexibility, this PDRA considers operations that should be performed in Visual Line of Sight
- 61 (VLOS) of the remote pilot. The operations should be conducted over controlled ground area that is
- 62 entirely located in a sparsely populated environment. Operations over controlled ground
- automatically lead to a GRC appropriate for SAIL II operations, without the need to use mitigations
- that could reduce flexibility. It is also meaningful to require controlled ground, as this PDRA is
- designed for testing purposes, during which the likelhood for failures might be higher than usual.
- 66 A maximum height of 150 m above the overflown surface of the earth is considered for the
- 67 operational volume. The operations take place in airspace considered as low encounter airspace
- 68 (ARC-b). This can be uncontrolled airspace or controlled airspace with a coordination with the local
- 69 ANSP.
- 70 In addition, the UA operator should establish an air risk buffer if the competent authority or the
- 71 entity responsible for the airspace management considers necessary establishing such buffer.
- 72 The PDRA requires basic containment and provides suggestions, which may be used use to comply
- 73 with the requirements considering the nature of the PDRA. These include an analysis of the UA
- 74 system, a tether or a flight termination system.
- 75 Operators may perform automated flights, conducting the UA operation according to a
- 76 preprogrammed path uploaded on the flight control system of the UA.

2. Annex A: Risk assessment for PDRA-06

The following risk assessment has been conducted by applying SORA to the PDRA-06.

3.1 Step #1 – CONOPS description

UA operators that intend to perform a UA operation under this PDRA should elaborate a concept of operations (ConOps) which includes an Operational and Technical Manual. This ConOps needs to fit the operational limitations defined in this PDRA.

As part of the ConOps, the UA operator should define the required operational volume and risk buffers (ground and air risk buffers).

3.2 Step #2 — determination of the intrinsic UA ground risk class

The initial UA ground risk relates to the unmitigated risk of a person being struck by the UA (in case of loss of UA control) and can be represented by the Ground Risk Classes (GRC) derived from the intended operation and the UA lethal area, as shown in Table A1 below.

- This PDRA is intended for UA operations in airspace with a low encounter rate with manned aircraft (ARC-b). ARC-b in the framework of this PDRA is understood as an airspace:
 - below 150 m AGL in uncontrolled airspace (class F or G) over rural area, with a coordination with local airfields if applicable;
 - below 150 m AGL in controlled airspace with a coordination with the local ANSP; or
 - below 150 m AGL in an airspace with a low encounter rate (ARC-b) which, for the purpose of this PDRA, is as defined by the competent authority.

A competent authority may decide to create a specific area that is designated as a test site for UA operations. Such a test site may have a restricted airspace that was specifically established to allow safe operations of UA. To make this PDRA also applicable to such operations, the following is considered:

³ This mitigation is meant as a means to reduce the number of people at risk.

⁴ This mitigation is meant as a means to reduce the energy absorbed by the people of the ground upon impact.



• An operation under this PDRA is also possible in a reserved or restricted airspace that is established and approved for the purpose of the UA operation. The air risk for such an airspace may be considered as ARC-a.

Therefore, this PDRA makes no specific difference between the operational requirements and procedures for flights in an ARC-b and ARC-a. This does not have an influence on the SAIL II classification. The final GRC is 3, which does not allow SAIL I.

- 301 The initial ARC is ARC-b.
- 302 No strategic mitigation to decrease the initial ARC is included, the final ARC remains as ARC-b.
- The operation may take place in Visual line of Sight of the pilot.
- For VLOS operations, the operator is required to have a deconfliction scheme to address the potential risk of collision with other airspace users.
 - As indicated in SORA, the competent authority, ANSP, or U-space/UTM service provider, may elect to directly map the airspace collision risks using airspace characterisation studies. These maps would directly show the initial Air Risk Class (ARC) for a particular airspace. If the competent authority, ANSP, or U-space/UTM service provider provides an air collision risk map (static or dynamic), the UA operator should use that service to plan UA operations in an airspace that is characterised as ARC-b.
